By requiring additional concrete/asphalt surfaces, it will make it more difficult to design functional neighborhoods and mixed use community centers. The additional requirement for concrete/asphalt will make designing new communities more difficult as developers balance existing impervious regulations, building set-back requirements and budgets. The City should follow the already established Federal ADA and PROWAG designs, without unique additions and exceptions. There is no need to create wider sidewalks and smaller intersections for a town where vehicular transportation is a necessity to access food, medical treatment, employment, education and other means of living. Time and resources should be being spent addressing mass public transportation, versus redesigning pedestrian crossings.
